INSURANCE

Vendor assumes entire responsibility and liability for any and all claims and/or damages of any nature or character whatsoever with respect to the event also including all products and / or services offered and represented are covered by this Vendor Agreement and Vendor agrees to defend, indemnify and hold harmless Discover Lansdale, Lansdale Borough, its affiliates, parents and subsidiaries, the owner of any store front, any other Vendor that the Vendor may be obligated to defend and indemnify in the Main Contract, from and against any and all claims, demands, liabilities interests, loss, damage, fires, penalties, attorney's fees, costs and expenses of whatever kind or nature, including property damage or for personal injuries (including death) to any and all persons (whether such persons are employees of Vendor's, or others) resulting from the event covered by this contract. This indemnification expressly extends to (but is not in any manner limited to) any claims, damages or suits for infringement or violations of patents or patent rights, Vendor further agrees that the indemnification contained in this section shall not in any manner be limited by the applicable provisions of any Workers' Compensation Act and, for this purpose, Vendor waives its rights to immunity as an employer under any such Workers' Compensation Act in the event of a claim by one or more of its employees against Vendor (or any other party whom Subcontractor is obligated, by this paragraph, to indemnify) and Vendor further waives any defense.
